### **Archery Range Safety Rules:**

- The Moorman Park Archery Range is surrounded by private land and busy park sites that are within the range of an improperly released arrow. Archers are solely responsible for the safe flight of all arrows released and may be held criminally or civilly liable for any damage or injury caused by the arrows they release.
- No "Sky Pulling"! When drawing back the string of a bow, an archer shall not use the technique known as "Sky Pulling". Nocked arrows will be pointed in a safe direction at all times, they will be pointed directly down-range and BELOW the horizon at all times. Under no conditions will a shooter point a nocked arrow above the horizon while drawing the bow.
- A bow may be drawn only at a designated firing point and must be pointed at a designated target only.
- No Broadheads allowed on range.
- Never shoot an arrow until you are positive that no one is in front of you or behind the targets.
- Walk, never run toward the targets. Remember that the arrows are sticking out and can injure you.
- When pulling arrows out of a target, stand to one side and insure that no one is directly behind you.

- If you are looking for a lost arrow behind a target, always leave your bow leaning against the target face so that it will be seen by other archers coming up. If possible, have one archer from your group stand in front of the target to prevent anyone from shooting.
- If any person or animal (i.e. dog) enters the safety zone while shooting is in progress, all shooting must stop immediately. If the bow is held at full draw and the signal is given, the arrow must not be released. The bow should be pointed at the ground and the bowstring let slowly forward. The arrow should be removed from the bow until the range is clear.
- No archer should shoot while under the influence of drugs or alcohol.

Report unsafe acts to the Quincy Park District during business hours at 217-223-7703, after hours contact the Park Ranger at 217-316-4557, if an emergency call 911.

I agree to waive and relinquish all claims I or my minor child/ward may have against the Quincy Park District and its officers, agents, servants and employees as a result of using the archery range.

I do hereby fully release and discharge the Quincy Park District and its officers, agents, servants and employees from any and all claims from injuries, including death, damage or loss, which I or my minor child/ward may have or which may occur to me or my minor child/ward and arising out of, connected with, or in any way associated with activities involved in using the Quincy Park District's archery range.

I further agree to indemnify and hold harmless and defend the Quincy Park District and its officers, agents, servants and employees from any and all claims resulting from injuries, including death, damages and losses, sustained by me or my minor child/ward, arising out of connected with or in any way associated with the activities involved in use of the park district's archery range.

The range user assumes full responsibility for any damages or injury caused by their actions and will pay for any damages that they caused.

Insurance: The Quincy Park District DOES NOT carry medical or accident insurance for program participants. Please review your own personal health insurance program to be certain that you have proper coverage.
