### Quincy Park District COVID-19 Update: July 30, 2020

#### All sports are canceled for the 2020 fall season

Regrettably, we find ourselves having to make these difficult decisions during the COVID pandemic. The health and safety of our youth, coaches, parents, and our staff have been, and will continue to be, paramount throughout these unprecedented times.

- Due to the new restrictions issued by the Illinois Department of Health, Governor Pritzker and Adams County Health Department the Quincy Park District is cancelling all fall youth and adult sports for the safety of all involved.

- Youth, High School and College sports organization currently postponing or canceling fall season are as follows: IESA, IHSA, GLVC and NCAA Division II Sports

These activities, despite their importance in the development of youth, can never take precedence over the health and safety of those same youth as well as the health and safety of our community and parents/fans who attend these events. The Quincy Park District made a difficult decision but, in the end, staff simply felt that there are too many unknowns to proceed safely at this time.

### **COVID-19 Program and Facility updates based on restore IL**

#### **Indian Mounds Pool**

Indian Mounds Pool will not open for the 2020 season. It is the Mission of the Quincy Park District to provide safe, clean, family-friendly facilities and programs to the Quincy Community. We continue to monitor the current COVID-19 public health crisis and make operational modifications and adjustments that comply with the current Executive Order as well as promoting public health through outdoor recreation.

On April 30, 2020 Governor J.B. Pritzker signed Executive Order NO. 2020-32 extending the stay-at-home restrictions statewide through May 30, 2020. Executive Order NO. 2020-32 is available online at <http://www2.illinois.gov/Pages/Executive-Order2020-32.aspx>.

Staff believes there is a wide variety of summer programming the Quincy Park District can modify that will fit within the Centers for Disease Control (CDC) and the Illinois Department of Public Health (IDPH) guidelines for the 2020 summer season. We will make every effort to modify these programs with our park patrons' safety at the forefront of our decision-making process. There are numerous summer programs we are able to modify and new programs we can offer to comply with the ever-changing public health guidelines, staff does NOT believe the operation of Indian Mounds Pool is one of them.

The CDC currently advises park users not to use splashpads, water playgrounds, or water park features and other frequently touched recreation equipment. Additionally, the Illinois Department of Public Health (IDPH) licenses all pools and splashpads within the State of Illinois. The IDPH is currently NOT allowing the operation of any swimming pools and splashpads within the State of Illinois. Washington Park Splashpad will remain shut off until "Restore Illinois" reaches Phase 5 which will likely be sometime in August.

- Groups of 10 or less, social guidelines applied, sanitize equipment after each use

#### **Fishing Clinics**

- Free to the public

- Begins June 9
- Groups of 10 or less, social guidelines applied, sanitize equipment after each use

#### **Nature Programs**

- Free to the public
- Begins week of June 29
- Groups of 10 or less, social guidelines applied
- Scheduled for Bob Bangert Park and Gardner Park Trail

#### **Special Populations Activities**

- Cancelled for 2020.

#### **Summer Playground Activities (No Playgrounds)**

- Free to the public
- June 15 – July 31, M-F
- Groups of 10 or less, social guidelines applied, sanitize equipment after each use
- Bob Mays, Johnson and Wavering Parks 10:00 am – 12:00 pm
- Ben Bumbry Riverview, Madison and Reservoir Parks 1:00 pm – 3:00 pm

#### **Youth Soccer, Baseball, Softball, T Ball, 3 on 3 Basketball, Sand VB**

- Cancel the spring and summer season
- Fall soccer league starting August 17
- Fall baseball and competitive league baseball starting August 17
- Softball, T Ball, basketball and sand volleyball leagues starting August 24
- No summer tournaments

- Opening May 30
- Follow social distance guidelines
- Sanitize equipment after each use

- Free to the public

- These events are cancelled through Phase 4 of Restore Illinois

- Follow social distance guidelines
- Scheduled times for different age groups
- Machine pitched

#### **Soccer Shootout Fun Day**

- Free to the public
- Starting the weekend of July 18 and 19

- Follow social distance guidelines, sanitize equipment
- Scheduled times for different age groups
- Youth will have a chance to participate in different soccer games/drills

#### **Northwest Community Programming**

- Free to the public
- June 15 – July 31, M-F
- Follow social distance guidelines, sanitize equipment
- Ben Bumbry Riverview Park for summer playground from 1:00 pm to 3:00 pm

#### **Free Throw, Three Point Contest**

- Free to the public
- Begins the weekend of July 25 and 26 at the multi-purpose courts at Moorman.
- Follow social distance guidelines, sanitize equipment
- Scheduled times for different age groups

- Will be stocked with soap and materials for drying hands

#### **Quincy Park District COVID-19 Update: March 23, 2020**

The Governor of Illinois has issued a shelter in place for the entire state of Illinois until April 7<sup>th</sup>.

- Any special events in the parks will be cancelled.
- Restrooms scheduled to be open April 1<sup>st</sup> will remain closed.

- All group programming classes, activities and events hosted by the Park District are suspended. Park District staff will be working to reach out to those affected in the coming days.
- All facility rentals are canceled. Park District leadership will evaluate facility rentals for April based on the continued development of information on COVID-19.

#### Quincy Park District COVID-19 Update: March 16, 2020

Due to the pressing need for social distancing and in an effort to support this initiative, the following will be put in place by the Quincy Park District effective Monday, March 16 at 12:00 pm through the end of the month. This includes closing the indoor playground at 1231 Bonansinga Drive. All activities at the Lorenzo Bull House, 1550 Maine Street have been postponed through the end of this month.

**All outdoor parks will remain open including Westview Golf Course.**

**Park District staff will reach out to our customers, programs participants, event organizers, and those who have a facility reserved, with more information over the next two weeks.**

- Park District programs that do not exceed 25 participants will continue as planned. Staff will properly sanitize the facility and equipment before and after use. If a program is canceled, you will be contacted directly by the instructor or other Park District staff.
- We encourage all sports participants and teams not to hold practices until the end of the month.

If you choose to visit our parks, you are urged to follow the recommended protocol as outlined on the CDC Website <https://www.cdc.gov/> including:

- Stay home when you are sick
- Wash your hands often with soap and water for at least 20 seconds or use hand sanitizer that contains at least 60% alcohol.
- Avoid close contact with others.
- Avoid touching your eyes, nose, and mouth.

Quincy Park District continues to monitor the rapidly changing COVID-19 outbreak. Staff and Board remain committed to providing wellness opportunities for our community within the guidelines and

recommended protocol provided by the CDC (Center for Disease Control), IDPH (Illinois Department of Public Health) and IPARKS (Illinois Parks Association Risk Services).
